## Attachment 2: General sales conditions

### Tournement accommodation

**Hotel accommodation** The teams will stay, according to the requests and availability, in selected hotel facilities. All the hotels are heated and correspond to the official hotel classification. Coaches, managers and escorts will be accommodated in double rooms, while rooms with 3 or 4 beds they will be mainly reserved for players and families with children as a result. Normally every 20 person, upon supplement, can book a single room. **THE NAMING OF THE HOTEL ACCOMMODATION WILL BE COMMUNICATED TO THE TEAM, NOT BEFORE 7 DAYS AT THE BEGINNING OF THE SPORT EVENT and in any case only after complete payment of the fees due.** The accommodation facilities can ask for a security deposit upon arrival of the groups will be returned upon departure after checking the rooms / housing units. **Registration of teams outside the hotel package will not be accepted.**

**Local taxes ATTENTION:** we inform you that all our hotel packages in the Catalog and on our websites do not include any taxes stay and any tourist bus transit fees as the Legislative Decree 14 March 2011 n° 23 gave the Italian Municipalities the power to establish the tax of stay on tourist services (Hotels, Campsites, Rooms, Hostels, Residences, Ticket Bus, Museums, etc.) for non-residents in the same municipality. Tax is optional and at the discretion of the municipalities and, especially as regards hotel services, it will not be the same throughout Italy but will depend on the Municipality itself and the number of stars of the chosen hotel; It is free for children up to a certain age and is to be paid directly to the hotel. For all these reasons it is not possible for us include it already in the prices of the proposed packages. **Discounts and gratuities** Discounts for children in room with 2 paying full price: 0-2 years free; 3-6 years 30% discount - Free: 1 for every 25 paying people (on the amount corresponding to the accommodation in a multiple room) unless otherwise communicated.

### General conditions of Sale

#### Mandatory Information - data sheet:

The proposed tour packages are governed by the general contract conditions and governed by the International Travel Contract Agreement (CCV) signed in Brussels on 23/4/1970 as well as by the legislative decree n.111 of 17/03/95 implementing Directive 90/314 / CE and subsequent amendments.

We summarize below the summary of the most important conditions:

**1) Bookings** - The reservation request must be written on a special registration form that must be completed in its entirety and signed by customer within the indicated terms. Acceptance of bookings is considered completed, with the consequent conclusion of the contract, only when the Organizer will send confirmation, also by computer or fax, to the customer. By signing the registration form, the petitioner declares to accept the conditions in the name and on behalf of all the participants of his team and he takes responsibility for the payment in the name of all the members of the group to which he is required to communicate the conditions for booking. The indications relating to the tourist package not contained in the contractual documents, in

brochures / catalog or in other means of communication, also electronic, will be provided by the Organizer in regular fulfillment of the obligations charged by Legislative Decree 111/95 in good time before the start of the trip (such as program matches, tournament regulations, name of the Hotel, etc.).

**2) Payments** - At the time of booking must be paid a deposit equal to € 1,500.00 (Euro one thousand five hundred / 00) for each registered team, while the balance must be made 30 (thirty) calendar days before the start or start of the sporting event. If reservations are requested within 30 (thirty) days of calendar before departure, the overall price of the trip must be paid in a single payment. Failure to pay the sums referred to above on the dates established constitutes an express termination clause which determines the termination of the right.

**3) Payment Methods** - By bank transfer directly to: Travel Srl ;

**4) Price** - The price of the tourist package is determined in the contract, with reference to what is indicated in the catalog or program out of the catalog and to any eventual updates of the same catalogs or out-of-catalog programs subsequently taken place. It may be changed up to 20 days before the departure only as a consequence of changes in: (a) transportation costs, including fuel costs (b) fees and taxes on certain types of tourist services such as taxes landing disembarkation or boarding fees in ports and airports (c) exchange rates applied to the package in question. For these variations, reference will be made to the exchange rate and the costs referred to above in force on the date of publication of the program as shown in the catalog or on the date reported in the eventual updates above. The oscillations will affect the lump-sum price of the tourist package in the percentage expressly indicated in the catalog or program out of catalog. Within 30 days of the start of the tournament, we reserve the right to calculate a supplement of 25 euros for each change you wish make your reservation (eg accommodation modification, number of participants, etc.)

**5) Consumer withdrawal** - The consumer can withdraw from the contract without paying penalties, in the following cases: • increase in the price referred to in the previous art 3 in excess of 10% • significantly modifies one or more elements of the contract that are objectively configurable as fundamental for the purpose of use of the package as a whole considered and proposed by the Organizer after the conclusion of the contract itself but before departure and not accepted by the consumer. In the cases mentioned above the consumer has the right to: take advantage of an alternative tourist package to refund of only the part of the price already paid. This return must be made within ten working days from receipt of the request repayment terms The consumer must give notice of his / her decision (to accept the modification or to withdraw) within and not later than two working days from when he received the notice of increase or change. In the absence of express communication within the aforementioned term the proposal formulated by the Organizer is considered accepted. To the consumer who withdraws from the contract before departure outside the hypotheses listed in the first paragraph will be charged - regardless of the payment of the deposit - in addition to the individual cost of management / practical opening or registration fee the penalty in following measures: 10% of the participation fee from the time of registration to 45 calendar days before departure 30% of the participation fee from 45 to 30 calendar days before departure 60% of the participation fee from 30 to 11 calendar days before departure no refund after these terms.

**6) Modification or cancellation of the tourist package before departure** - In the hypothesis in which prior to departure the Organizer will communicate in writing his / her own inability to provide one or more of the services covered by the tourist package proposing an alternative solution the consumer can exercise alternately the right to reacquire the sum already paid or to enjoy the offer of a proposed replacement tourist package. The consumer can exercise the above-mentioned rights even when the cancellation depends on the failure to reach the minimum number of participants provided for in the Catalog or in the Program out of print o from cases of force majeure and fortuitous events, relating to the tourist package purchased. **Force majeure** - our organization declines all responsibility in case of damages or thick due to changes or cancellation of your tournament, if these are due to force majeure that could not be foreseen or avoided in any way. Such causes include for example, the state of war, the threat of state of war, riots, terrorist activities, natural disasters or nuclear disasters, logistical problems of a technical nature, fires or adverse weather conditions, or similar causes of force majeure. Our organization does not take responsibility for your responsibilities and those of your group if the law or regulations of the states visited during your tournament.

**7) Obligations of the participants** - Participants must be provided with a document valid for all countries affected by the itinerary, as well as visas for stay and transit and health certificates that may have been requested. They must also comply with the rules of normal prudence and diligence and to those specifications in force in the destination countries of the journey, to all information provided to them by the Organizer, as well as to the regulations and provisions administrative or legislative provisions relating to the tourism package. The participants will be called to answer for all the damages that the Organizer should suffer due to of their non-compliance with the above-mentioned obligations. The consumer is required to provide the Organizer with all documents, information and elements in his possession useful for the exercise of the right of subrogation of the latter against third parties responsible for the damage and is responsible to the Organizer of the injury caused to the right of subrogation. The consumer will also communicate in writing to the Organizer at the time of booking the particular personal requests that may be subject to specific agreements on the travel arrangements provided that it is possible to implement them. It is recommended that each member of the group is covered by adequate travel insurance (not included).

**8) Complaints** - Any failure in the execution of the contract must be contested by the consumer without delay so that the Organizer, his local representative or the accompanying person will promptly remedy it. The consumer can also make a complaint by sending one registered, with acknowledgment of receipt, to the Organizer no later than 10 working days from the date of return to the place of departure.

**9) For anything not specified** in this contract, the rules governed by the International Convention relating to the travel contract (CCV) are valid signed in Brussels on 23/4/1970 as well as by the legislative decree n.111 of 17/03/95 implementing Directive 90/314 / EC and subsequent amendments.

**Closing registrations** Usually 30 days from the start of each tournament, subject to availability of seats.
